
# Health and Safety Overview

# Lead Accident Investigation Training

#### What is this Course?

This course has been designed at an intermediate level, set to provide you with the guidance and information you need to conduct investigations confidently.

#### What does it cover?

- Looking at investigations and what makes a good one
- Understanding the accident investigation process
- Developing an investigation plan and preparing effectively, including how to create a good team
- Explore accident prevention mindset and conducting strong conversations
- Identifying the range of evidence required in an investigation and how to use it to reach effective decisions
- Understanding root causes
- Holding interviews that are non-bias, fair and understanding human factors
- Recognising the underlying causes of accidents using human factors techniques

During the course we also delve into some tools and models that can help aid investigative work. And of course, as part of your investigations you need to be able to write up your report, so we will be looking at what a good report looks like and developing effective recommendations too.
